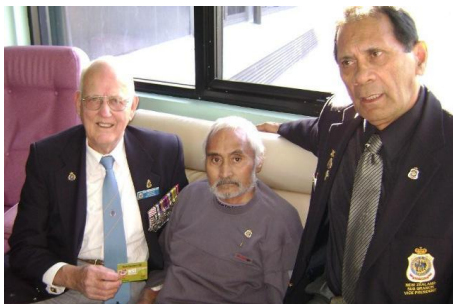

##### Veteran Assistance – Joe Riri and Rapata Wharerau

Dear Veterans, I thought I would pass on some information about two Veterans now living in NSW.

543332 Joe Riri Vietnam Veteran transferred to NSW from WA and has settled into his new home well. Joe and his partner Susan are both not well but have had immense support from his fellow Vietnam Veterans; Hank, Vic, Kevin, Larry as well as visits by NSW based Veterans, Brian, Taawhi and the President of the NZ Sub-Branch David Winkelmann and their wives Linda, Kathleen and Ann. In fact it was only through the efforts of these Veterans that Joe's relocation to NSW was managed with minimal problems but also ensured Joe received his medals by liaising with the appropriate organisations in NZ. It is nice to know that the camaraderie is strong within the Veteran community and remains so even when there is a little distance between us. Whilst technology shortens the distance, it can and never will replace face-to-face contact so thanks to those Veterans that helped, visited and will continually keep in touch with Joe in to the future.

Rapata is doing well now that he is closer to his family and Julie has sent an email expressing her thanks to Taawhi and Kathleen for their dedication and commitment to helping a fellow Veteran.

Dear Veterans, the NZ Veterans in NSW have been associated with the Sydney Maori Anglican Fellowship Church of Te Wairua Tapu for many years now and as a result have our own service at the Church for ANZAC Day which was initiated by Vietnam Veteran Clarence Ormsby. ANZAC Day in 2010 will more than likely be the same format as this and previous years. However, just to clarify, the term 'veteran' in today's context refers to all serving and ex-service



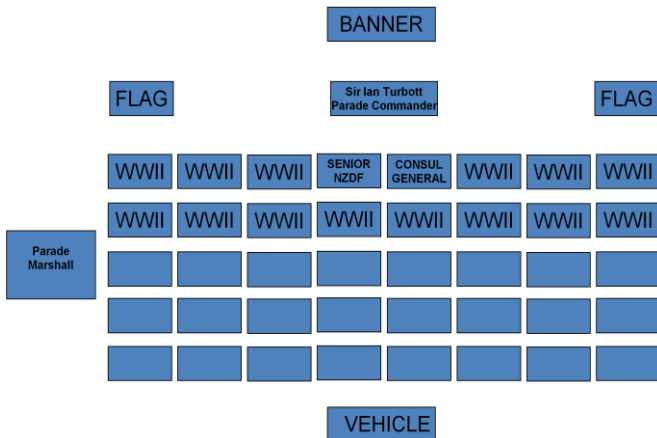

**Reminder: Veteran ANZAC Day Wreath-Laying Service at the NZ Soldier Statue on ANZAC Bridge – Sunday 2 May 2010**

Following on from the Church service a Wreath-Laying service will be held on the same day at 2pm in the afternoon. This year and hopefully future years the NZ Veterans are sharing this service with the Mortdale RSL Sub-Branch so that there will be a shared cost to the service. The intent is for the NZ Veterans to host in 2010 with Mortdale hosting 2011 and so on. The other benefit is that Archdeacon Malcolm Karipa will also officiate at this service when the NZ Veterans are hosting it. The service will be held under the bridge to ensure less distraction to vehicle traffic, with the Wreath-Laying service conducted at the Statues. There is limited room at the Statues and every effort is to be made not to hinder the general public who also have a right to visit the Statues. Nevertheless, the actual Wreath-Laying part of the service is very short. As with the service this year it is hoped that we will get approval from Sydney Ports Authority to use the same parking area and also RTA approval. It would be a good opportunity to see the Statue albeit whilst attending the service.

**Notice from Kiwi Vets re Commemorations Fund**

There is an advertisement in the latest issue of Contact regarding battlefield tour to Vietnam being organised by Ray Farrell. The advertisement states that "Ex Vietnam War Veterans are eligible for a refund of the airfare component (\$1,800)" .... from VANZ.

It may be useful to set out the detail regarding the fund and approval process. Pretty sure of my facts but anyone is at liberty to point out any errors.

1. The fund is titled the Minister of Veterans' Affairs Commemorative Fund. It has an annual allocation of around \$200,000 (I think), The fund provides grants to help subsidise the cost of reunions at \$10 per veteran up to a maximum of \$5,000, funding for special projects such as exhibitions, memorials and booklets to a maximum of \$5,000 and subsidies to



veterans returning to battlefield sites they were involved in to a maximum of \$2,000 per veteran.

2. The travel subsidy is only available to NZ Vietnam veterans i.e. Aust VVets resident in NZ are not eligible but NZ VVets resident in Aust or elsewhere are.

3. Any grant made is calculated on the basis of the return airfare component of the trip.

4. The \$2,000 is a one time grant. If you went to Vietnam twice and the first time you received say \$1,800 you could apply a second time but all you could plan on getting is \$200.

5. Those who have been lucky enough to score a VANZ trip to Gallipoli are deemed to have used up their \$2,000.

6. It's a case of first in, best dressed and once the yearly allocation has been committed then that's that (for that year). The financial year runs from 1 Jul to 30 Jun so for the Farrell trip departing 19 April 2010 I would advise you to get in quick.

7. You need to complete a special application form. You can access the form via Freephone 0800-4838372 or download from the VANZ website [www.veteransaffairs.mil.nz](http://www.veteransaffairs.mil.nz)

### Mangere man glad to be part of Samoan reconstruction effort

Mangere Soldier Sapper John Rickard recently had his first overseas deployment

with the New Zealand Army, assisting Samoans impacted by the Tsunami.

"The Tsunami had been devastating, all I could think was what a mess it had made," said John.

"Its good to be getting involved, I'm enjoying doing some practical work that will help the Samoan people. My first deployment was a long time coming, but worth waiting for."

John, a carpenter, has been in the Army for 12 years. He has recently completed his carpentry apprenticeship after previously working as an Army driver.

John is part of 2 Engineer Regiment based at Linton Military Camp near Palmerston North. He is in Samoa as part of a 12-strong section of Army engineers providing relief support to Samoans impacted by the Tsunami. The team is made up of carpenters, electricians, plumbers and engineering plant operators.

The team have been working in close conjunction with the Samoan Water Authority building water supply infrastructure and latrines for temporary communities in the hills around the Saleapaga village area.

"Its great to be here helping out and great to see the end product we are creating."

Over 150 personnel from the Navy, Army and Air Force have participated in a whole of Government approach to assist the Governments of Samoa and Tonga by working with NZAID, the



Ministry of Civil Defence and Emergency Management, the Ministry of Health, the Ministry of Foreign Affairs and Trade, NZ Police, the Ministry of Pacific Island Affairs, NZ Customs, The Ministry of Civil Defence and Emergency Management, NGOs and the Australian Defence Force.

### Tactical flying in South Island Exercise

The skies above Tekapo will be buzzing with the sound of Iroquois

helicopters from the Royal New Zealand Air Force's Number 3 Squadron as Exercise Steel Talon gets underway.

The exercise runs from 8-22 October, and will see up to six Iroquois and over 100 Air Force personnel based out of Tekapo Military Camp.

Detachment commander for the exercise, Flight Lieutenant Ben Stephens says Steel Talon is the Squadron's major tactical flying exercise of the year.

"For aircrew this means the opportunity to train in tactical operations, using a number of aircraft and flying as low as 50 feet, while ground crews will be practicing maintenance support from a remote location."

"This training will maintain our capability to deploy overseas if requested by the Government. Exercises such as Steel Talon have given us the ability to contribute to Operations in East Timor, the Solomon Islands and Bougainville over the past decade."

The first three days of the exercise will see an initial deployment of three Iroquois from No. 3 Squadron working alongside soldiers from the New Zealand Army's 2/1 Battalion, Royal New Zealand Infantry Regiment. The remaining three helicopters will arrive in Tekapo on 11 October.

Flying operations will be conducted mainly over the Mackenzie Basin, around Omarama airfield, Otomatata and Tekapo areas and Lake Pukaki and will include some limited night flying.

The helicopters will be fitted with Mag58 door mounted machine guns and firing blanks during the exercise. There will be no live firing at any time.

IN REMEMBRANCE



### President RNZRSA

Here for information is an excerpt from what I said to the 350+ who were at the RNZRSA Council's Welfare Forum last Monday afternoon. It follows the same line I have mentioned elsewhere in recent weeks, including the Affiliates Forum on 9 September, and NEC:

There is a most important policy matter that we will have to face and to tackle head-on.

The matter of interpretations of the current Act is contentious at the moment; we all know that. But there are much wider implications here for the shape of our future legislation. As you all know, the gateway to our present system is the War Pensions Panels, where two people judge the merits of an application case-by-case against the law, and in great detail. One of these two people is an RSA nominee, and the other a VANZ nominee. Above that there are several layers of appeal opportunity. And at each of these levels, further judgements are made.

This is the way we are. Belief in the shared discretionary system is deep. And we reflected this in our submission to the Law Commission, at around paragraph 85. Although we hedged around it a bit, we said that the majority view from the consultations was to opt to retain the discretionary system we now have rather than change to the prescriptive-style system the Australians have, based upon Statements of Principles.





Having stirred things up because of the re-write and the upheavals within VANZ, however, the reality is that some uncomfortable truths are now emerging. Assumptions are being challenged as focus draws in on just how difficult, even incomprehensible, some of the provisions in our law really are. The result is constant arm-wrestling with VANZ over perceptions of changing rules as case-by-case judgements become known.

But if we stand back from all this a bit, an examination of the frictions that have arisen with VANZ over recent months shows clearly that they are almost entirely because of the wide discretionary powers built in to our law. Where there is discretion, interpretation is required. And where there is interpretation there will also be disagreement based on points of view. This is so especially where interpretations of the law are as difficult as they are in our system, where the detailed case-by-case assessments are done by a number of panels so that consistency, too, is hard to achieve. With a more defined system such as the Australian SoPs, however, matters should be less open to interpretation, with clearer, less contentious and more consistent results. This is certainly the Australian experience. In that case most of the adversarial disputes that are currently a feature of our system would not be happening.

This particular matter will become a critical issue – perhaps the critical issue - in discussions yet to take place as the re-write continues. Veterans' organisations including us should prepare for this, and should do so with an open mind in order to be constructive in the best interests of veterans. Where sufficient reason exists to reconsider our view, or even to change our minds in this area, we should not be shy about doing so. We must get this right, and we must get it right the first time because there will not be a second chance. And in all of it we should not overlook that we do now have the independent Expert Panel, which is ideally suited to be a principal arbiter in what should or should not be set out in the prescriptions.

In other words we need to take into account the machinery we now have which we have not had before. And we also need to take into full account that all I am really talking about here is formalising and extending the presumptive lists that we already have and that are working well.

Some might be concerned over possible effects on the bedrock “reverse onus of proof” currently in our system. Sir Geoffrey and others have given us an absolute commitment to retaining that principle, although more clearly worded. This can be done in one or both of two ways. First, it can be embodied into relaxed standards of proof associated with presumptive lists or SoPs. The Australian system already strikes two different standards of proof for each SoP – the “Reasonable Hypothesis” where the proofs required are set very low, and “Balance of

Probabilities” which requires a tougher standard; the one applies to war service and the other to routine service. Otherwise the reverse onus can be left wholly in place as a safety net for the few items that won't fit into presumptive lists or SoPs. For those cases the processes would be much as they are now, with the great majority of cases being dealt with by presumption.

This is what we need to think about, and think about very carefully.

Just to make the point quite clear, what I am saying is that the RNZRSA is prepared to re-think its position on a prescriptive system if there is reason to do so. I don't yet know what the answers are going to be. But there is good reason to keep an open mind.
